

What is a CLT?

A Community Land Trust (CLT) is a not-for-profit organisation working for the good of the community.

Run by volunteers, a CLT strives to meet the longterm needs of its community. Its mission and objectives will be geared to the needs expressed by the community be they in respect of housing or creating/managing local assets.

It is always run BY the community, for the BENEFIT of the COMMUNITY.

Why was EBCLT Created?

The adopted Neighbourhood Plan, prepared by the Parish Council, makes provision for a specific project to create a community land trust as the means of delivering homes for local people and to deliver housing for shared ownership and renting, mainly for young families and older people.

EBCLT's structure enables housing developments to be retained for the long-term benefit of the community.

EBCLT's Mission and Vision

Mission - To deliver the housing needs of East Bergholt in accordance with the Neighbourhood Plan and deliver and maintain community assets for the long-term benefit of the village.

Vision – Serve the community of East Bergholt by creating a self-sustaining, not for profit entity to provide, manage and sustain homes not being provided by others.
